# FOSTER TOWNSHIP OFFICIAL COMMENTS TO THE PROPOSED ACT 537 PLAN AMENDMENTS

The recently adopted Foster Township Comprehensive Plan anticipates significant future land development in areas of the Township not currently served by SCMA. The Comprehensive Plan lists as a major goal the provision of adequate future facilities to serve anticipated growth in the municipality. Major new land development plans are soon to be submitted by Reading Anthracite for both residential housing and commercial development within Foster Township. Therefore, Foster believes the amended 537 plan should include a provision that sewage treatment services for future residential and commercial development within Foster Township may be provided by the Minersville Sewer Wastewater Treatment Plant in the Delaware River Basin.
